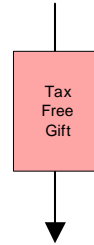
Dashed Line Indicates Future Structures

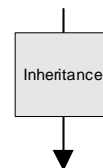
Individual (Person) Small Circle Over Larger Circle. Straight Hair Represents Men and Curly Hair Represents Women.

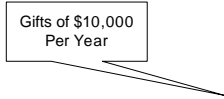

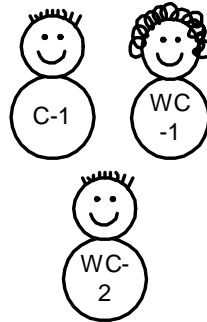

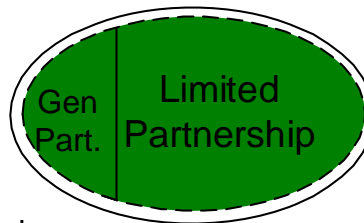

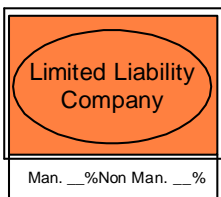
Ownership of Property by Entity. Ladder Under Figure

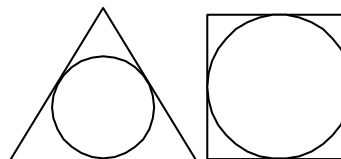
Partnership, Limited (Goose Egg)



Limited Liability Company Double Lines Indicate Eternal and Internal Legal Protection

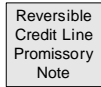


Probate Estate (Tombstone)



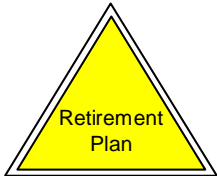

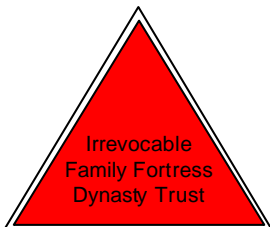
Uniform Gifts To Minor Acts
